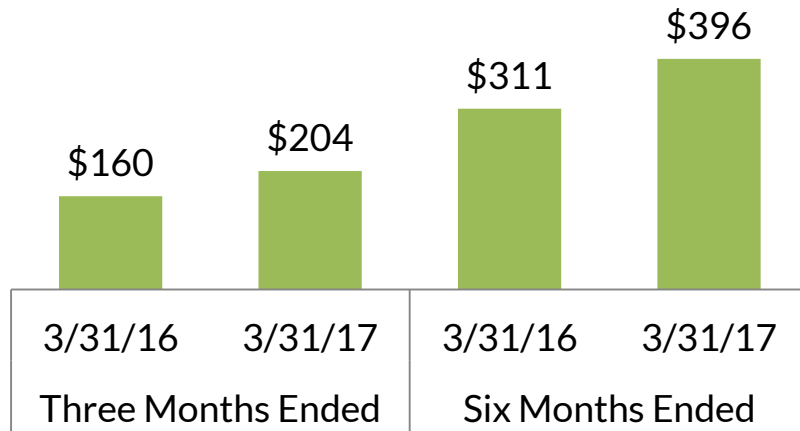

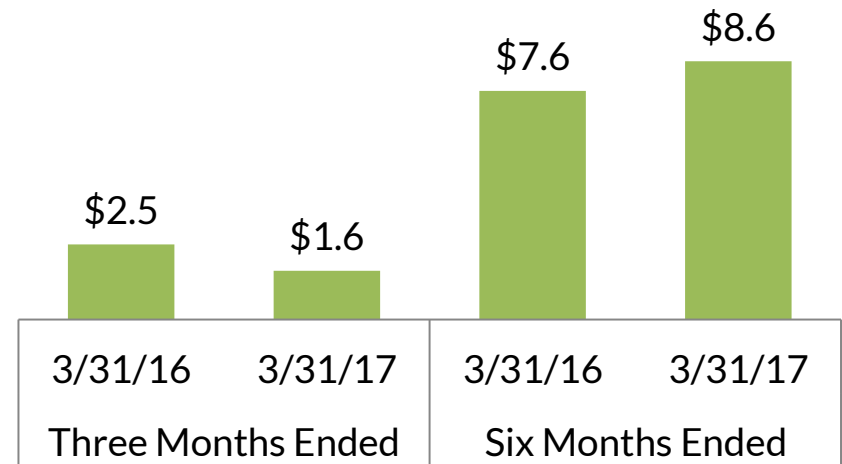

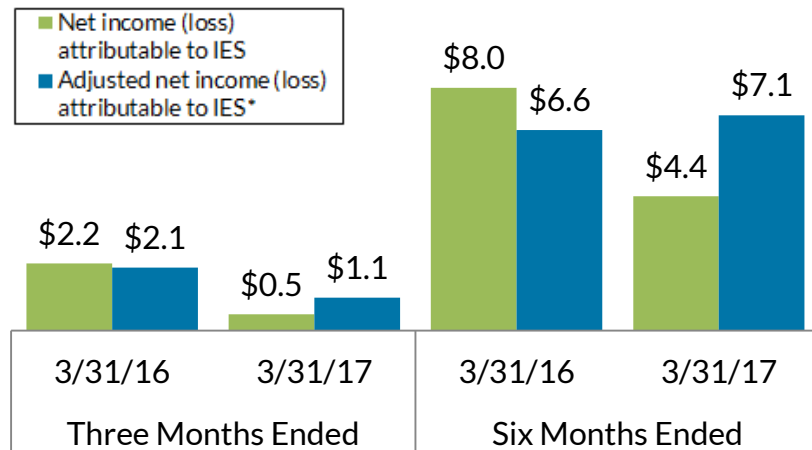
REVENUE



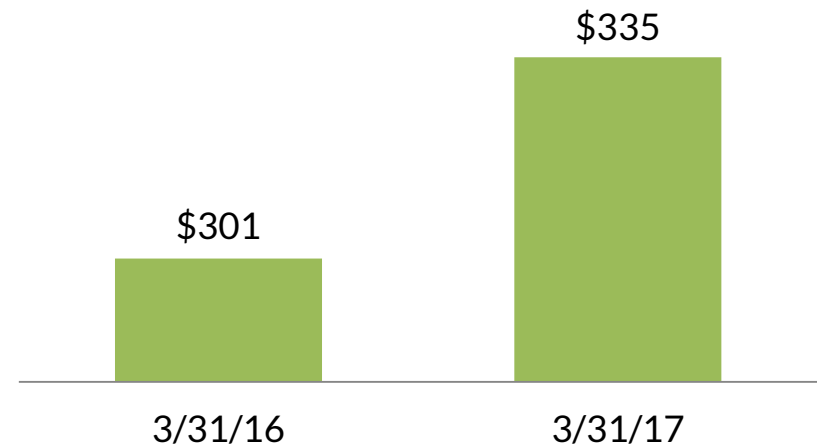
OPERATING INCOME

Second Quarter 2017 Highlights

◆ Revenue

- \$203.7 million, an increase of 27.3% compared with the 2nd quarter of FY16 (“2Q16”)

◆ Income from Operations

- \$1.6 million, a decrease of \$0.9 million compared with 2Q16

◆ Earnings

- Net income attributable to IES of \$0.5 million, or \$0.02 per diluted share
- Adjusted net income attributable to IES (a non-GAAP financial measure; see supplemental disclosure table) of \$1.1 million, compared with \$2.1 million for with the 2Q16

◆ Completed Acquisition

- Infrastructure Solutions segment acquired Freeman Enclosure Systems, LLC on March 16, 2017

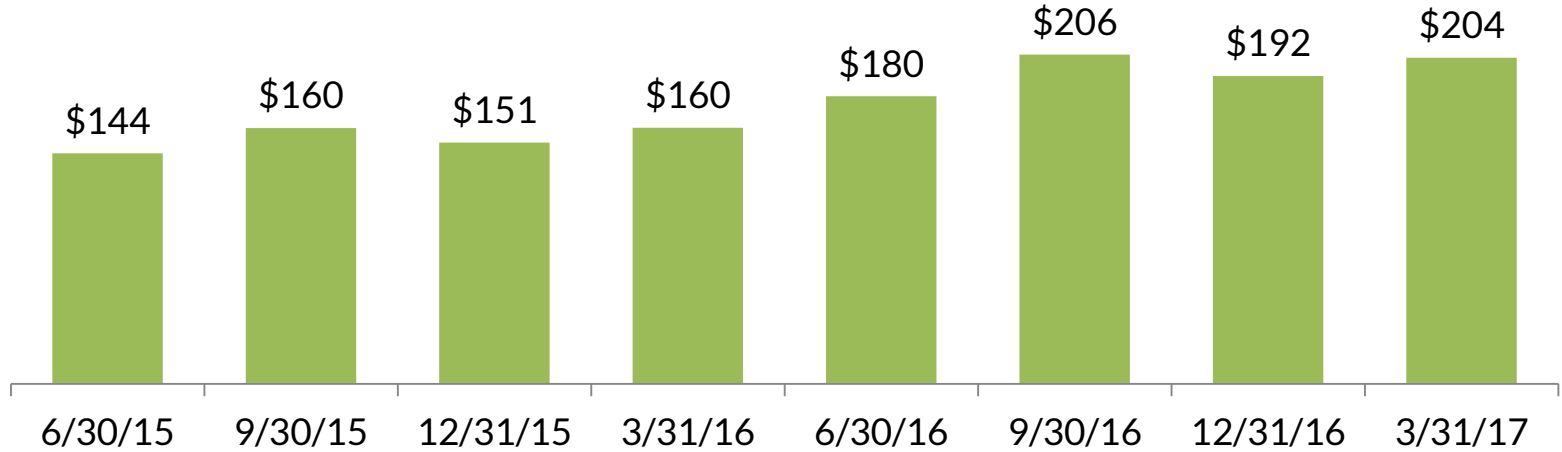

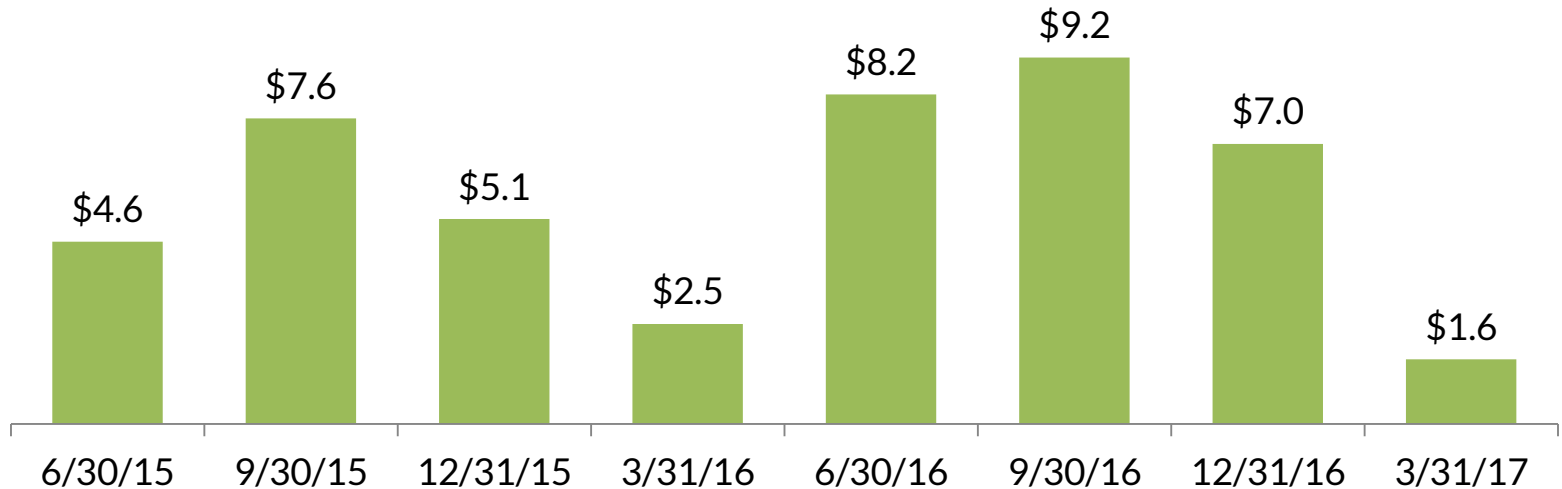

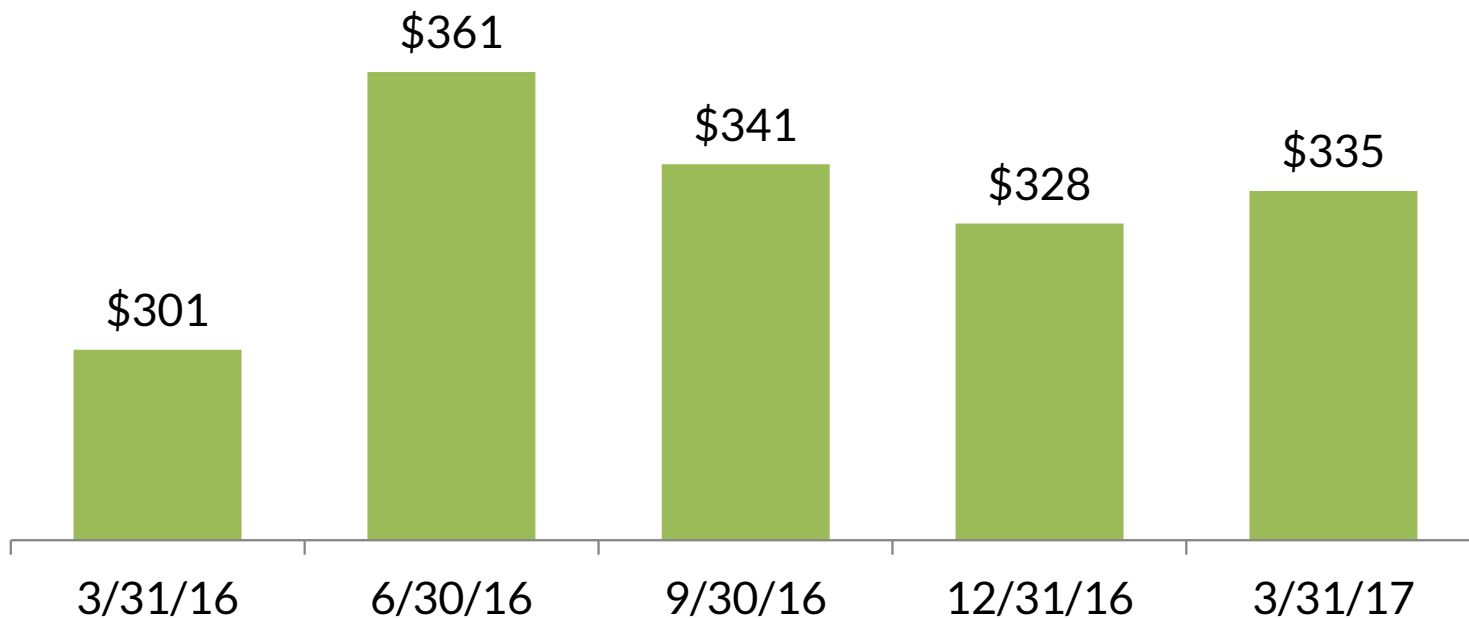


Operating

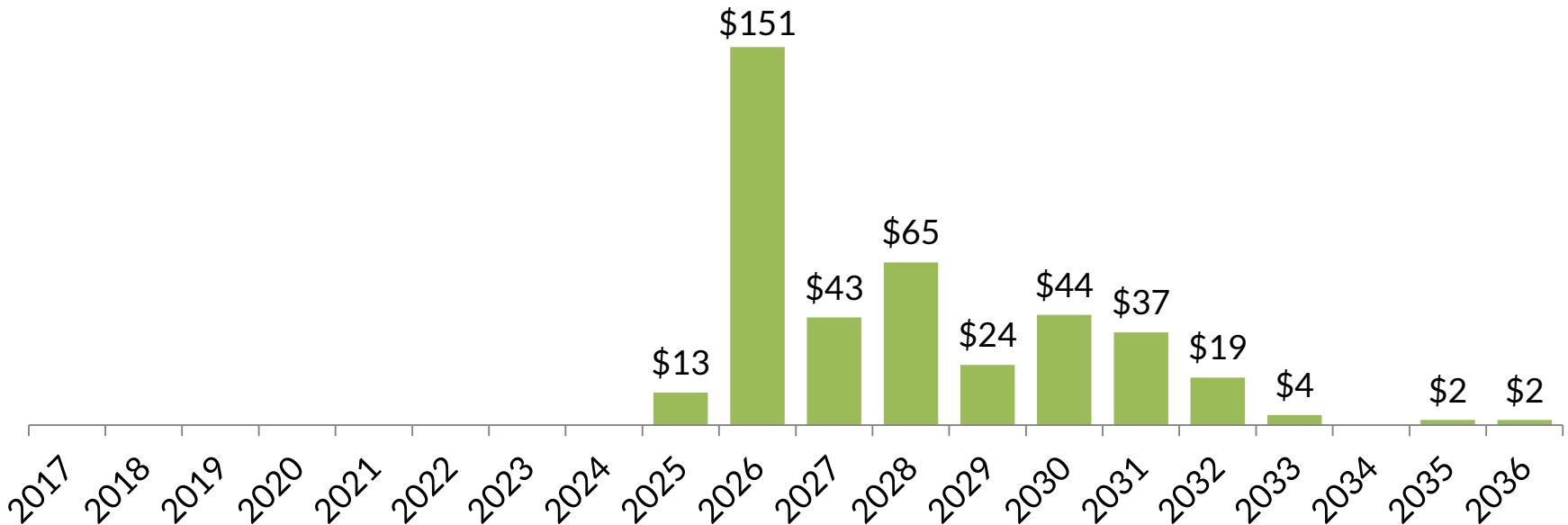
